

RESOLUTION NUMBER 6672

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS AMENDING RUBBISH COLLECTION CHARGES AS PERMITTED IN SECTION 7.16.050 (D) OF THE PERRIS MUNICIPAL CODE AND RESCINDING RESOLUTION NUMBER 6188.

WHEREAS, the Consumer Price Index has increased by 3.30% and the County of Riverside has increased their landfill disposal fees by 2.88%; and:

WHEREAS, said increase is necessary to defray these costs by increasing the rates and charges to the recipient of various services.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris as follows:

Section 1. Pursuant to 7.16.050 (D) of the Perris Municipal Code, the rates and charges of Chapter 7.16 are adjusted as follows:

“Section 7.16.050 Rubbish Collection, Disposal, and Street Sweeping”

1. A monthly charge for rubbish collection, transfer, disposal, and street sweeping services is hereby levied upon each occupied household and business establishment, in accordance with the following rates:

(a) Residential

- (1) Single family residences, mobile homes, apartments, condominiums, townhomes, bungalow courts, and multiple residences per dwelling unit, using 100-gallon individual receptacles.

Monthly Rate: (includes recycling fee) \$37.06

- (2) Single family residences, mobile homes, apartments, condominiums, townhomes, bungalow courts, and multiple residences per dwelling unit, using 60-gallon individual receptacles.

Monthly Rate: (includes recycling fee) \$30.82

- (3) Additional 100-gallon individual receptacles.

Monthly Rate: \$12.01

- (4) Additional 60-gallon individual receptacles.

Monthly Rate: \$10.45

- (5) Residential organics rate per home (add to item 1 & 2)
