

RESOLUTION NUMBER 6684

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA APPROVING THE FIRST AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF PERRIS AND LOCAL 911 OF THE CALIFORNIA TEAMSTERS PUBLIC, PROFESSIONAL AND MEDICAL EMPLOYEES UNION FOR THE PERIOD JULY 1, 2025 THROUGH JUNE 30, 2027

WHEREAS, the City of Perris (“City”) has recognized the California Teamsters Public, Professional And Medical Employees Union, Local 911 (“Local 911”), as the sole exclusive employee organization for that bargaining unit defined and described as wall-to-wall, non-exempt white and blue collar employees, including part-time employees, as more fully detailed in the Attachment “A” of the current Teamsters MOU 2025-27 for all matters concerning wages, hours and working conditions; and

WHEREAS, the current Memorandum of Understanding between the City and Local 911 is effective July 1, 2025 through June 30, 2027 (“Teamsters MOU 2025-2027”); and

WHEREAS, Teamsters Local 911 notified the City that Teamsters Local 911 and California Teamsters Public, Professional And Medical Employees Union, Local 986 (“Local 986”) have merged effective June 1, 2025 resulting in a change in representation from Teamsters Local 911 to Teamsters Local 986 for City represented employees; and

WHEREAS, the City and both Teamsters Local 911 and Local 986 desire to memorialize this change in representation for purposes of the existing Teamsters MOU 2025-27; and

WHEREAS, it is the desire of the City Council of the City of Perris to approve and adopt an amendment to the Teamsters MOU 2025-27 to memorialize and confirm the change in employee organization representation.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The foregoing recitals are true and correct and are incorporated reference herein.

Section 2. The City Council of the City of Perris does hereby accept, approve and adopt the First Amendment to the Memorandum of Understanding between the City and Teamsters Local 911, a copy of which is attached hereto as Exhibit “A” and by this reference made a part hereof.

Section 3. The City Council of the City of Perris does hereby recognize Teamsters Local 986 as the sole exclusive employee organization for that bargaining unit defined and described as wall-to-wall, non-exempt white and blue collar employees,

including part-time employees, as more fully detailed in the Attachment "A" of the current Teamsters MOU 2025-27.

Section 4. The City Clerk shall certify to the adoption of this Resolution.
