

**RESOLUTION NUMBER 4465**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, OF SUPPORT FOR THE PERRIS AND MENIFEE VALLEY REGIONAL AQUATICS CENTER**

**WHEREAS**, The County of Riverside, the Board of Supervisors, and Economic Development Agency recently approved the development and construction of the Perris and Menifee Valley Regional Aquatics Center; and,

**WHEREAS**, the County of Riverside has invested approximately \$25 million towards the development of this multipurpose aquatics center to serve the Perris Valley region for use as a family oriented recreational facility; and,

**WHEREAS**, the County of Riverside has also designed the aquatics center for athletic competition as it incorporated a competition length pool and diving facility in compliance with California Interscholastic Federation standards; and,

**WHEREAS**, the design and construction of this state of the art aquatics center will promote general physical fitness and health and is of great benefit to the physical fitness and health of youths, their families, and senior citizens; and,

**WHEREAS**, the Perris and Menifee Valley Aquatic Center will be a regional facility, serving the residents of several unified school districts, the cities of Perris and Menifee, and the unincorporated communities of Lakeview and Nuevo.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, as follows:

**Section 1.** The City of Perris hereby expresses its desire to assist the County of Riverside in the annual cost of operations and maintenance of the Perris and Menifee Valley Aquatics Center.

**Section 2.** City staff is directed to share in such annual costs through a memorandum of understanding with the County of Riverside for the operations and maintenance costs of this facility over a period of time and upon terms which are mutually agreeable to all parties.
